

A metric by which to evaluate COL's pass rate record is the Committee of Bar Examinations (CBE) "minimum cumulative bar pass rate" (MPR) rule, Guideline 12.1, which requires CBE-accredited law schools to maintain a cumulative pass rate on the California Bar Exam of 40% over a five-year period for bar takers who graduate within a specified time frame. California's three-day bar exam is one of the most challenging in the nation, with a pass rate that typically hovers around 50%. The Juris Doctor programs at Santa Barbara and Ventura exceed the CBE minimum pass rate of 40%.
